First serving as a district court judge deciding over 16,000 cases over 12 years, then serving as an Associate Justice, Chief Justice and Senior Justice on the New Mexico Supreme Court. Barbara has presided over and decided thousands of cases involving complex legal and constitutional issues impacting all segments of society.

In 2021, Barbara was named and served as Cabinet Secretary of New Mexico Children, Youth and Families Department. She brought extensive insight and commitment to improving the public child welfare system in New Mexico.

Since 2024, Barbara has owned and operated a successful mediation and arbitration firm assisting parties in settlement negotiation to resolve matters in dispute.

A tenacious, dedicated and respected leader developing and implementing improvements to the administration of justice and public child welfare system.
