Harold Oehler is a full-time federal and state certified mediator. He serves on the Executive Council of the Florida Bar's Alternative Dispute Resolution Section and the Florida Bar's Consumer Protection Law Committee. He is the primary author of the *Florida Mediation Best Practices Handbook* and created the "Litigator Mediator Forum" to provide trial lawyers and mediators a platform to collaboratively improve the mediation process. Harold received the Florida Bar ADR Section's 2022 "MVP Award" for most outstanding contribution towards improving mediation in the State of Florida.
