Hugh M. Robert is a partner in the firm of Sherwood & Robert. He graduated from the University of Tulsa College of Law. His undergraduate degree is also from the University of Tulsa. He practices in the areas of complex litigation including business transactions, business torts, business dissolution, real estate transactions, health care law, and real estate condemnation. Hugh serves as outside general counsel to non-profits, for-profit businesses of varying sizes handling contracts, business acquisitions, real estate transactions, human resources matters, and risk assessments. He also practices in the area of complex estate planning and probate. He represents and works with non-profit foundations and organizations advising them on state and federal compliance issues, policy and procedure best practices, intellectual property and licensing, and board governance issues. He has also served as an arbiter for contract disputes, collective bargaining actions, employee discrimination, consumer contracts, and nursing home negligence/personal injury cases.

While at the University of Tulsa College of Law, he served as Articles Editor for the peer-reviewed Energy Law Journal. He was a member of the Phi Delta Phi honors fraternity. He was on the Dean's honor roll and held several offices in the Law & Medicine Society. He received a number of awards including the Outstanding Service Award from the Law & Medicine Society, Phi Delta Phi Professional Responsibility Award, and Cali Awards (highest grade) in Mental Health Disability Law, Civil Procedure, Pre-Trial Practice, and Professional Responsibility. He also received the Martin H. Belsky Award in Public Interest Law for his demonstrated commitment in the areas of public service, diversity, religious respect and promotion of constitutional values in 2008.

He founded and served as Executive Director of the non-profit organization Oklahoma Center for Consumer & Patient Safety, which later became OKWatchdog, a 501(c)(3) organization. He was responsible for the identification of policies and practices that impact consumer and patient safety and bring about change in those areas. He was awarded the Consumer Advocate of the Year by the Oklahoma Association for Justice in 2007 for his work with the organization.

He currently serves as the Secretary and Trustee to the Kappa Sigma Endowment Fund, is the Audit Committee Chair and on the board of directors for the Oklahoma Center for Nonprofits, on the board of directors of Parkside Psychiatric Hospital & Clinic and American Bank and Trust. Hugh is the co-founder of Lawyers Fighting Hunger, Inc. a 501(c)(3) foundation that raises money to help feed the hungry and partners with other non-profits across the state of Oklahoma. He has served as the President on the International Board of Directors of the Kappa Sigma Fraternity, President of the Alumni Board for the University of Tulsa College of Law, CLE Chair for the Hudson Hall Wheaton Inns of Court, Membership Committee Chair of the Tulsa County Bar Association, and Iron Gate Board of Directors.

He was awarded The University of Tulsa College of Law Distinguished Young Alumni in 2010. He received Iron Gate's Volunteer of the Year award, volunteer under 40 award in 2011, and honored in 2019 at Iron Gate's Founder's Dinner for his work with Lawyers Fighting Hunger.
