Fla. 2016), which have helped shape Florida's legal landscape in areas including contract law, insurance law, and trust and estate law.

Maloney Memorial Writing Contest for his article entitled "*Barefoot in the Dark: Is the Sunshine State Sleeping on Public Rights to Beach Access?*" Mr. Cummings was named a Florida Rising Star in 2012 through 2019 and a Barrister of the Chester Bedell Inn of Court in 2013 through 2016.
