

Joseph L. Daly

Biographical

Joseph L. Daly is presently an Emeritus Professor of Law at Mitchell Hamline School of Law in St. Paul, Minnesota. He is an Arbitrator and a Mediator who does practices locally, nationally and internationally. He is a qualified ADR neutral under Rule 114 in Minnesota.

Prior to becoming a professor, he was a partner and trial attorney in a Minneapolis law firm where he tried civil and criminal cases.

From 1974 until his retirement in 2012 he taught "Litigation Practice", "Arbitration: Theory and Practice", and ran the Employment Discrimination Clinic where he trained law students how to ethically and professionally represent actual clients in civil rights claims before the EEOC and the State of Minnesota Department Human Rights. He was the "Robins, Kaplan, Miller and Ciresi Distinguished Professor of Litigation and International Dispute Resolution" at Hamline Law School.

A Fulbright Scholar in Alternative Dispute Resolution for three years at the University of Montevideo, Uruguay, South America, where he continues to today as a Visiting Professor teaching one- week intensive courses: "Resolving International Business Disputes by Arbitration" and "ADR and American Litigation." He was named by the Fulbright Foundation as a "Senior Specialist in Peace & Conflict Studies" (2005-2009).

Prof. Daly is an Arbitrator and Mediator locally, nationally and internationally. He has arbitrated over 1,000 cases and written hundreds of fully reasoned decisions, many of which are published in *Bloomberg Labor Arbitration Reports*. Mediated more than 500 cases, many of them court-ordered.

He has lectured on "Dispute Resolution" in Vietnam, Cambodia, Hungary, Romania, Albania, The Philippines, Bahrain, China, Hong Kong, Uruguay, Norway, Sweden, United Kingdom, France, Poland, Kenya, Cameroon and Australia.
