Joshua Martin became a partner at the law firm of Potter Anderson & Corroon LLP in March, 2005. He concentrates his law practice on mediation and arbitration and on business counseling, particularly in the areas of telecommunications, public utilities and governmental relations. He was Chair of Potter Anderson's Diversity and Inclusion Committee from 2005-2016. He retired from the Partnership in December, 2013 and is now Senior Counsel with the firm.

His Alternative Dispute Resolution (ADR) experience includes multi-million dollar settlements in highprofile private mediation cases, in addition to substantial experience as an arbitrator in private arbitration matters and in Delaware Superior Court Rule 16 matters. He taught ADR at Widener Law School from 1986-1995 and judicial mediation at the National Judicial College from 1988-1990. Mr. Martin was on the Special Master Panel of the U.S. District Court in Delaware until 2015 and has served as a Special Master for the District Court in the Eastern District of Pennsylvania. He was elected a Fellow of the prestigious College of Commercial Arbitrators in 2016 and elected in 2018 to the Tech List of the Silicon Valley Arbitration and Mediation Center. He has served as an arbiter in a number of related matters including as a hearing officer in healthcare cases and special master in various types of civil matters.

In January, 2009, Joshua Martin was appointed by Delaware Governor Jack Markell to chair the Delaware Economic & Financial Advisory Council (DEFAC), the public-private council that forecasts state revenues and expenditures used by the governor and Legislature to prepare state budgets and to determine state fiscal policy. In 2015 he chaired the DEFAC Advisory Council on Revenues and was appointed a member of the Delaware Expenditure Review Committee, which issued its report on state spending in 2016. In 2017, he was appointed by Governor Carney to the Council on Development Finance, an advisory entity which considers matters relating to economic development and strategic opportunities for the State of Delaware.

In May, 2007, Mr. Martin was jointly selected by the Delaware Department of Correction and the United States Department of Justice to serve as the Independent Monitor overseeing the progress of an agreement relating to prison medical and mental health care in four Department of Correction institutions.

Mr. Martin was President and Chief Executive Officer of Verizon Delaware Inc. and its predecessor company, Bell Atlantic Delaware Inc., from 1996 until early 2005. Mr. Martin oversaw all aspects of Verizon's telecommunications business within the State of Delaware, including regulatory, financial and operational matters. Mr. Martin joined Verizon as Vice President, General Counsel and Secretary of the Delaware Company on January 2, 1990.

Prior to joining Verizon, Joshua Martin was a Delaware Superior Court Judge for eight years. Earlier, he served on the Delaware Public Service Commission from 1978 to 1982, including three years as Chairman.

After obtaining his law degree, Mr. Martin joined Hercules, Incorporated, where he was a patent attorney until 1982. Mr. Martin began his professional career as a physicist at the DuPont Company in 1966.
