#### **DESCRIPTION OF PRACTICE:**

Upon retirement from the Superior Court, returned to law practice in an “of counsel” position with the law firm of Sell & Melton, L.L.P. in Macon from 2011 to June 30, 2016. Effective January 1, 2017, has moved his practice to Clark, Smith & Sizemore, LLC, also in Macon. Private practice is limited almost exclusively to mediation services, tort and insurance litigation, including the following areas: motor vehicle, products liability, medical malpractice, common carrier (trucking), railroad, and general insurance litigation. Has served regularly as a mediator in tort cases since 1988, the majority of which involve personal injuries and wrongful death.
