PROFILE

Lawrence H. Fleischman has been providing creative alternatives to litigation in Tucson for over 40 years. A former Pima County Superior Court Judge, he was known as the “settlement judge” and founded the first Center for Dispute Resolution in the Arizona Superior Court system, saving litigants and taxpayers millions. Since transitioning from the bench, he has successfully settled over 9,000 cases, ranging from complex business disputes to wrongful death claims and environmental litigation. A charter member of the Arizona Chapter of the National Academy of Distinguished Neutrals, he also co-negotiated one of the largest sports endorsement deals in history—Andre Agassi’s Nike contract.
