Lynn P. Cohn is the Director of the Center on Negotiation and Mediation at Northwestern University Pritzker School of Law and was awarded the Harry B. Reese Teaching Chair. She has developed and taught courses in negotiation, mediation, mediation advocacy, conflict management and problem solving. Professor Cohn received the student-voted Outstanding Professor of a Small Class Award and the Dean's Teaching Award. She has been elected to the Leading Lawyers Network in the categories of ADR Commercial and ADR Employment and the National Association of Distinguished Neutrals.

Professor Cohn has trained lawyers, real estate professionals, management and union representatives, government employees, community groups and corporate employees in effective negotiation, mediation, conflict management and arbitration techniques. Professor Cohn has also served as an arbitrator or mediator in over 4000 cases with an emphasis on employment, Title IX and commercial disputes. In 2013, Professor Cohn was appointed as the Special Master in the *McReynolds v. Merrill Lynch* Settlement. In this role, she was responsible for the distribution of \$160 million to claimants alleging racial discrimination in their employment. Since then, she has fulfilled this role in numerous other matters.

Professor Cohn is a frequent speaker and writer on negotiation and mediation topics.
