Because of my experience as a trial lawyer, including successfully trying at least one of the largest construction trials ever in Maricopa County, as well as many other construction trials, and my experience as an engineer and general contractor, I can, when requested, offer evaluations of the various parties' positions, risks, and expectations. Many of my past mediations were successful because of these evaluations.
