Tom Cordell has over 40 years of legal experience, during which time he has taken in excess of 50 cases to jury trial. He has participated as counsel in over 600 mediations during his litigation career. Tom retired from the active practice of law in 2021, focusing his skills in the arenas of mediation and arbitration. Tom obtained formal mediation training at the Pepperdine School of Law Straus Institute on Dispute Resolution. He has mediated cases as a panel mediator with Dispute Resolution Consultants since 2019.

Tom obtained his undergraduate degree in English Literature from Oklahoma State University in 1976, and his Juris Doctorate degree from the University of Idaho in 1979. He was admitted to practice law in Oklahoma in 1979. From 1979 to 1981, he served as an Assistant District Attorney in McClain County. In 1981, he joined the law firm of Huckaby, Fleming & Frailey. He became a partner in 1985. He practiced as a senior partner in the Chickasha, Oklahoma law firm of Frailey, Chaffin, Cordell, Perryman & Sterkel until September 2020, when he joined Wilson Cain and Aquaviva as *Of Counsel*.

During his years of active practice, Tom was engaged in an all facets of tort litigation, focusing on complex tort and commercial litigation, construction defect, oil and gas litigation, bad faith, insurance defense and coverage litigation, personal injury, premises liability, products liability, auto liability. He is a member of the Order of the Barristers. He is a recipient of the Maurice Merrill Golden Quill Award, given by the OBA annually for the outstanding published article in the

Oklahoma Bar Journal.
