

Wade McMullen limits his practice to Mediation and Resolution of Civil disputes. After trying lawsuits for the first fifteen years of his career, Wade turned his focus to exclusively concentrate on Mediation and Resolution of Civil disputes in State and Federal Court for the past twenty-five years.

In that time, he has mediated over 11,500 cases. He offers half day, full day, evening and weekend Mediation dates and frequently travels outside of Fort Worth to conduct Mediations. McMullen has mediated to successful resolution a wide range of disputes (from 2 parties to 120 parties) including personal injury, employment, insurance, business and commercial disputes, oil and gas, professional malpractice, construction, environmental, real estate, condemnation, dramshop, intellectual property, wrongful death, banking and municipal matters.



McMullen has served as a Director on the State Board of the Texas Association of Defense Counsel. He is AV Rated in Martindale Hubbell Law Directory and has been listed in the Martindale Hubbell Bar Register of Preeminent Lawyers. He served as Chairman of the Nominations Committee in Fort Worth and is a Life Member of the Texas Bar Foundation. He served as a Barrister in the Eldon B. Mahon Inn of Court. McMullen is a Charter Member and has served on the Board of the Tarrant County Bar Foundation.

McMullen served as President of the Tarrant County Bar Association in 1999. Prior to that in 1991 he was elected Chairman of the Board of Texas Young Lawyers Association. He has served on the Board and as Secretary of Dispute Resolution Services of Tarrant County and has been designated as a Master Mediator by DRS. He is currently a Director of the Texas Attorney Mediator Coalition and is a member of the National Association of Distinguished Neutrals (NADN).

As a member of the State Bar of Texas, McMullen has been appointed to and served on the State Bar Qualifications of the State Judiciary Committee, State Bar Lawyer Referral Service Committee, Standing Pattern Jury Charge Committee, the Public Affairs Committee and the Advisory Committee to the State Bar President in 1996. He is a past Panel Chairman of the District 7-A Grievance Committee for the State Bar.

In May, 2000 he received the first Professionalism Award given by the Texas Center for Legal Ethics and Professionalism and the Tarrant County Bar Association. This award was set up to honor an Attorney or Judge who "best exemplifies by conduct and character, truly professional traits that others in the bar seek to emulate". Since its inception he has annually received the Attorney of Excellence Award as one of the top 100 Lawyers in Tarrant County. From 2003 through 2026 Wade received designation as a Texas Super Lawyer. Wade was selected to be listed in the 2006 - 2026 Editions of "The Best Lawyers in America" and was voted as one of the "Top 100" Attorneys in the Dallas/Fort Worth Region.
